Summary Annual Report

MACHINISTS HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the Machinists Health and Welfare Trust Fund (Plan) (EIN 91-1363505, Plan No. 501) for the year beginning August 1, 2019 and ending July 31, 2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees of Machinists Health and Welfare Trust Fund has committed itself to pay certain medical, vision, accidental death and dismemberment, life and dependent life insurance, short term disability, and dental claims incurred under the terms of the Plan.

Insurance Information

The Plan has contracts with Kaiser Foundation Health Plan of Washington, Kaiser Foundation Health Plan of the Northwest, LifeMap Assurance Company, UnitedHealthcare of Oregon, Inc., UnitedHealthcare of Washington, Inc., Regence BlueCross BlueShield of Oregon, Asuris Northwest Health and Union Labor Life Insurance Company to pay medical, life and dependent life, and short term disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending July 31, 2020 were \$2,922,588.

Basic Financial Statement

The value of Plan assets, after subtracting liabilities of the Plan, was \$44,878,245 as of July 31, 2020, compared to \$36,439,759 as of August 1, 2019. During the plan year, the Plan experienced an increase in its net assets of \$8,438,486. This increase includes unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the Plan had total income of \$32,212,884 including employer contributions of \$28,874,768, employee contributions of \$459,671, earnings from investments of \$2,877,281 and other income of \$1,164.

Plan expenses were \$23,774,398. These expenses included \$1,831,278 in administrative expenses, and \$21,943,120 in benefits paid to participants and beneficiaries. (Administrative expenses include administration fees, investment fees, auditing fees, attorney fees, banking fees, consulting fees and miscellaneous expenses.)

<u>Additional Information</u>

The U.S. Department of Labor has indicated that certain benefit obligations are to be omitted from the plan's Form 5500 and Summary Annual Report. Consequently, the estimated premium liability for the Alaska Group of \$1,148,351 and the lag months eligibility coverage of \$2,990,000 has been omitted from these documents. If included, the value of the plan net assets would be decreased from \$44,878,245 to \$40,739,894 and the change in net assets would decrease from \$8,438,486 to \$8,569,373.
